Tetangga 013 - Rukun Warga 007, Subdistrict Lebak Bulus, District Cilandak, South Jakarta, the holder of Resident Identity Card number 09.5308. 250751.0138, an Indonesian citizen, in this matter acting in his capacity as the Secretary General and by virtue of the power of attorney stated in the Minutes of the 47th Governing Council Meeting dated 28-4-2005 (the twenty-eighth day of April two thousand and five) and the Minutes of the 21^{st} General Assembly dated 29-4-2005 (the twenty-ninth day of April two thousand and five), each of which was privately drawn and duly stamped and attached to the original of this deed, as such and therefore for and on behalf of and validly represented the association "ASIAN LEASING ASSOCIATION", domiciled in Jakarta;

The appearer is known to me, Notary.

The appearer acting as mentioned above, first states as follows:

A. That based on the deed of the Articles of Association of the Association "ASIAN LEASING ASSOCIATION", dated 1-7-1997 (the first day of July one thousand nine hundred and ninety-seven) number 1, drawn up before me, notary, it was established an Association "Asian Leasing Association", domiciled in Jakarta



- (hereinafter referred to as "Asian Leasing
 Association");
- B. That it was convened the Governing Council Meeting of Asian Leasing Association on 28-4-2005 (the twenty-eighth day of April two thousand and five and the General Assembly of Asian Leasing Association on 29-4-2005 (the twenty-ninth day of April two thousand and five);
- C. That pursuant to the provision of Article 5.3 point c and Article 6.5 of the Articles of Association of Asian Leasing Association, the General Assembly and the Governing Council are authorized to make the amendment to these Articles of Association and/or By-Laws;
- D. That at the General Assembly Meeting and the Governing Council Meeting of Asian Leasing Association, it was determined to amend the Articles of Association and/or By-Laws of Asian Leasing Association as follows:
- 1. Name: from Asian Leasing Association to become Asian Leasing & Finance Association;
 - The management term of the President and Secretary General: from 1 (one) year to become 2 (two) years;



- 3. The term of member of the Governing Council from once in 1 (one) year to become once in 2 (two) years.
- E. Therefore, the appearer hereby wishes to explain the intention to amend the provisions of Article 1, Article 8.1, Article 8.2 and Article 8.3 of the Articles of Association of Asian Leasing Association as stated in the deed dated 1-7-1997 (the first day of July one thousand nine hundred and ninety-seven) number 1, drawn up before me, notary, in connection with the Decision of the General Assembly Meeting and the Governing Council Meeting mentioned above, so that thereafter the provisions of Article 1, Article 8.1, Article 8.2 and Article 8.3 of the Articles of Association of Asian Leasing Association will be written and read as follows:

Article 1

NAME

The name of association is "ASIAN LEASING & FINANCE ASSOCIATION" (hereinafter referred to as ALFA)

Article 8

THE OFFICERS

- 8.1 The officers of ALFA below must be appointed by the General Assembly once every 2 (two) years at the annual meeting:
 - a. one President;



- b. one Vice President and one Second Vice President
 of each county member, unless if there is any
 change from the association or national
 committee of its country, provided that a Vice
 President shall not be appointed from the
 originating country of the President; and
- c. one Secretary General.
- 8.2 The nomination for the appointment of such officers must be submitted to the Secretary General, at least 14 (fourteen) days before the date of meeting. All nominations must be submitted in writing and signed by the nominator. If there is only one nomination for a certain position, the nominee shall be appointed automatically at the relevant meeting, and further at the same meeting, it may be proposed to vote for the appointment of officers to hold other positions. If there are sufficient nominations, the voting will be conducted for such nominations at the relevant meeting.
- 8.3 Each officer shall hold his/her position as of the closing of the meeting where he/she is appointed until the closing of the next 2 (two)-years meeting, provided that if there is a vacancy in a certain position at the meeting, the officer holding such position shall remain in his/her position until his/her replacement is appointed.



Further, the appearer in her capacity as mentioned above states that this amendment to the Articles of Association of Asian Leasing Association constitutes as an integral and inseparable part of the deed dated 1-7-1997 (the first day of July one thousand nine hundred and ninety-seven) number 1, drawn up before me, notary, and any matters which are not amended and/or added with this deed will remain effective and bind the Members of Asian Leasing Association;

For this deed and all of the consequences, the appearer chooses the general and permanent legal domicile at the Registrar's Office of East Jakarta District Court in Jakarta.
